Chair's report

- Tugrul O. and Sanjib B. wrote to NB Chancellor inquiring about the following resolution (Nov. 11, 2019)
- Resolution on Inclusion of the Faculty Councils in the RU Policy Library
- NBFC received the following response
 - *Regarding the council's request to modify the Rutgers Policy library to more clearly identify the various university faculty councils, I have initiated a conversation with Dr. Barbara Lee, SVP for Academic Affairs, to see if these changes may be possible. I will get back to the NBFC as I learn more.*

Chair's report

- Information request by NBFC (Nov. 1, 2019)
 - *The Faculty & Personnel Affairs Committee of the New Brunswick Faculty Council has become aware of at least a few instances of program or center directors who are non-tenure track (NTT) faculty members. The F&PA committee would like to assess how widespread this practice is at Rutgers-New Brunswick. For this purpose, the Faculty Council would like to request from your office a list of names and ranks/titles of faculty members who are serving as directors of programs or centers at Rutgers-NB. The Faculty Council would like to analyze this information to see if we could recommend certain guidelines for when this practice may be appropriate or not. Although many schools have bylaws that stipulate that departments chairs need to be tenured, directorship of programs and centers is not addressed in the bylaws.*
 - *In addition, the Faculty Council would like to obtain aggregate data on the numbers of faculty members who are tenured, tenure-track, and NTT in each department and division (including Libraries and Agriculture Extension) within Rutgers-NB. The purpose here is to see how teaching and administrative loads are distributed among tenured, tenure-track, and NTT.*
- NBFC received the following response
 - *We are gathering information on any NTT roles as center or program directors. Provost Prabhas Moghe will address this topic at the next full NBFC meeting.*

Dear Dr. Rabinowitz,
